

1. Specifics of co-operation

 1. The payment for the certificate course in sign language (30I4RS) will be Rs.1500 per student plus GST.
 2. The payment for the certificate course in clinical management of learning disability will be Rs.1500 per student plus GST.
 3. The payment for the internship programme would be Rs.1500 per student plus GST respectively.

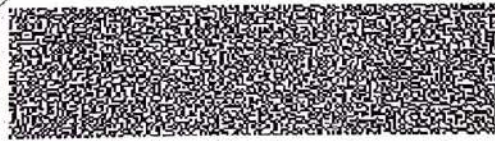
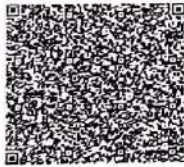
